IN FISCAL YEAR 2020, 1,132 INDIVIDUALS WERE PROVIDED SHELTER BETWEEN BOTH SHELTER LOCATIONS.

THIS PROGRAM OFFERS ASSISTANCE WITH THE HOUSING SEARCH, APPLICATION FEES, AND REFERRALS TO BRIDGING FOR FURNITURE, BUT NO ONGOING RENTAL ASSISTANCE OR CASE MANAGEMENT. 66 FAMILIES, INCLUDING 95 ADULTS AND 151 CHILDREN, AND 45 SINGLE ADULTS WERE SERVED IN FISCAL YEAR 2020.
